# INTRODUCTION

Local government is the first contact of citizens with the leadership, making them directly feel the achievements or failures of local institutions. A broken road, a protracted project, uncollected waste, roads not de-iced, are just some of the examples of daily confrontations, which ultimately affect the reduction of citizens' trust in public institutions, add to this the high perception of widespread corruption in public spending. The more closed the institutions are, the more suspicions are raised and the dissatisfaction of the citizens increases.

High institutional transparency helps increase confidence in good governance through accountability in public activities. But transparency without the involvement of citizens in development processes and informing citizens may not prove successful in this subject given the volume of information and their complexity, but also the needs of citizens. Furthermore, in the way of bringing citizens closer to local governments, increasing the efficiency and effectiveness of public spending, stimulating free competition and economic development at the local level, it is of particular importance that institutions possess the instruments that preserve integrity and ethics. institutional. One of the key elements in this regard is the elimination of political influence and professional and dignified representation in municipal enterprises and organizations, which if managed successfully can be very fruitful not only for citizens but also the institutions themselves, or vice versa can be harmful both in the provision of services and in increasing the financial burden on municipalities. Moreover, increasing transparency and active citizenship also help the institutions themselves in improving and advancing their performance.

For the seventh year in a row, the Kosovo Democratic Institute (KDI)/Transparency International Kosovo (TIK), through the publication of the Transparency Index in local government, continues to shed light on municipal spending and encouraging institutions to improve the quality of services provided for citizens and the promotion of active citizenship. The purpose of this Index is to inform citizens about the level of transparency and efficiency with which local governments provide goods, jobs and services, and to encourage institutions to carry out more efficient and transparent financial planning and spending as needed by the community.

# EXECUTIVE SUMMARY

In 2021, although facing the economic challenges caused by the COVID-19 pandemic, as well as the early central level elections and local elections, the municipalities proved to be quite proactive and accountable to its citizens.

In order to stimulate the most transparent municipalities, in 2021, KDI has adapted 46 new indicators from the methodology of Transparency International Slovakia, adapted by many branches of Transparency International in the European Union, including Kosovo in 2017, thus increasing the number of indicators used during the period 2017 - 2020 from 41 to 87, extending to eight public policies such as public procurement at the municipal level, public budgeting and finance, access to documents and public information, public participation, grants and subsidies, professional ethics and conflict of interest, public property management and municipal enterprises and organizations. Out of 87 index indicators. 51 of which are product indicators that measure whether the planned activities and actions are being implemented as provided or required by law and 12 performance indicators that measure the quality of the product / activity of the municipality and 24 complementary indicators that have no points but complement the history of other indicators.

Although in 2021, most measurements are based on new indicators, the index gives us a satisfactory result with an average of **56%** in the eight public policies addressed.

The year 2021 showed a positive trend in transparency in public procurement at the municipal level, marking an increase of about 13% compared to the same indicators within this governing policy from an average of 57% in 2020 to an average of 70% in 2021. During 2021, 30 out of 38 municipalities have published procurement planning on their website, of which 19 were in readable formats (Word, Excel, PDF Machine Readable). 26 out of 38 municipalities have published on their website the annual procurement report for the past year, of which 20 were in readable format and six were scanned documents. 32 have published a list of all executive bodies, public institutions and organizations, which regulate or handle procurement advice and disputes, but only four had provided a description of the responsibilities of these institutions, 28 municipalities publish contract notices on the website, but only 15 of them publish 100% of the notices compared to publications in e-Procurement, 26 municipalities publish contract award notices on the website but only 12 municipalities publish contract award notices on the website compared to e-Procurement.

An **increase of 9%** was also recorded in budget transparency (from 64% in 2020 to 73% in 2021). 23 municipalities out of 38 had published the municipal investment plan on the website, 26 municipalities had published the budget on the Website of municipality, 19 municipalities had published the changes in budget allocations on the Website of municipality, 17 municipalities had published all quarterly expenditure reports on the website and 11 partially, 29 municipalities had published the annual summary budget report for the previous fiscal year on the website, 30 municipalities had published the Medium Term Expenditure Framework, and 28 municipalities had published the auditor's reports on its website

In 2021, there was an increase in demand for public documents **from 327 in 2020 to 745 in 2021**. Of these requests, 359 were related to public procurement procedures. There was also an increase in the number of municipalities that responded to the KDI request for information and based on information received from 34 municipalities 13 were rejected due to the protection of private data. KDI encourages all municipalities to continue with their commitment to increasing transparency and to review their shortcomings in this index for 2021 and to focus on increasing transparency in all pillars in 2022.





# RESEARCH Methodology

Kosovo Democratic Institute (KDI), the chapter of Transparency International (TI) for Kosovo in cooperation with Transparency International Slovakia, which is a leader in promoting transparency in local government throughout Europe, during 2021 have closely consulted public policies and opportunities to expand the measurement indicators in order to stimulate further growth of transparency at the municipal level, which would ultimately benefit their citizens.

This improved assessment methodology enriches the local government transparency index for 46 new indicators and two additional pillars (1) municipal property management and auctions, and (2) municipal enterprises and organizations.


For the Public Procurement Transparency Index for 2021, KDI has evaluated the institutional transparency of Kosovo municipalities against 87 indicators, grouped in eight thematic pillars.

As this is the first year of measuring transparency in 46 new indicators, this index of 2021 will serve as a basis for measurements and comparisons in the coming years. The methodology used in 2021 is merely a reflection of the methodology used in 2020 and the preliminary measurements from 2017. Since the number of indicators and indicator points do not provide the maximum combined score of 100, the weighted score is used for numerical scores that enable KDI to rank performance based on categories of different priority or importance levels. The number of indicators, the maximum points for the indicators per pillar and the weight of each pillar are presented in the table below.

\*\*\* Due to the non-functioning of the Procurement Review Body, in the index of 2021, the indicator "Does the municipality publish the decisions of the PRB on its website?" has not been measured, and the maximum scores of indicators in transparency policies in public procurement have been calculated 20 in total.

1. **Product Indicators** – There are product indicators that measure whether planned activities and actions are actually being implemented as provided or as required by law. These indicators rely on data extracted from powerful and verifiable sources, such as municipal or central government websites. These indicators take values from 0 to 2 points, as listed below:



2. **Performance Indicators** – There are 12 performance indicators that measure performance quality. KDI surveyors relied on these indicators to compare data and determine a percentage of performance. To compare the numerical scores of other indicators, these indicators are evaluated as described in the following table:



#### Assessment method used to award a certain number of points:

- **A** Analytical conclusion of the research team;
- **B** Mysterious purchase (volunteer engaged by KDI has made a request for public information without revealing affiliation with KDI)




## **COMPARATIVE ANALYSIS** 2014-2021

In 2021, KDI introduced a revised methodology that measures eight pillars related to transparency in public procurement, public spending, access to documents and public information, public participation, grants and subsidies, instruments for addressing corruption and conflict of interest in local government, municipal property management and auctions, as well as municipal enterprises and organizations. The same methodology was used for the 2021 measures. Although KDI modified the methodology to measure transparency in public procurement at the local government level by introducing six pillars and 41 indicators, it still retained the 19 initial indicators used in previous years, to enable researchers to continue to measure time trends against those 19 indicators.



The graph below shows the transparency trends in public procurement during the years 2014-2021.


#### Transparency in public procurement: comparison 2015 - 2021


The graph below shows the budget transparency trends during the years 2015-2020.

The chart below shows the transparency trends during the years 2015 - 2021 in the publication of auction notices by municipalities.


#### Trends of publishing public auctions on the website of the municipality 2015-2021

As we can see from the graphs above, in 2021, there was generally an increase in transparency in the **19** indicators mentioned above.



In 2021, there was an average increase of about **21%** in transparency in public procurement compared to 2020 (in the two historical indicators).

- <sup>2</sup> Moreover in 2021, there has been an average increase of about **5%** compared to 2020 in budget transparency in the three historical indicators.
- In the publication of auction notices for 2021, **64 notices** were published on the websites of municipalities but only 10 on the website of the PPRC.
- Compared to 2020, which was a pandemic year (COVID-19), the number of requests for access to public documents had increased by **386 requests**.

## **COLUMN I** PUBLIC PROCUREMENT AT THE MUNICIPAL LEVEL

In 2021, only 18% of Kosovo's public budget was spent through public procurement<sup>9</sup>. However, this process in Kosovo continues to be seen as one of the public policies with the highest risk of corruption. Kosovo in recent years has taken several initiatives to increase transparency in this public policy, making mandatory the publication of contracts and sPejaial mandatory conditions on the central public procurement platform. However, the first contact of the citizen with the government is the municipality. To assess the level of transparency in this public policy, KDI has measured the following 14 indicators:



- 30 out of 38 municipalities published their procurement plans on their websites, while 21 of them were in legible format;
- 32 out of 38 municipalities had published contacts of executive bodies, public institutions and organizations that regulate or address procurement councils and disputes on their websites, however only four (4) municipalities had described to citizens the roles and responsibilities of these institutions;
- 26 out of 38 municipalities have published the annual procurement report from the previous year on their websites, while 20
  of them were in legible format;
- 24 out of 38 municipalities have published all contract notices, 4 have partially published contract notices on their websites, while 10 municipalities have not published any notices;
- 22 out of 38 municipalities have published contract award notices, 4 have partially published contract award notices on their websites, while 12 municipalities have not published any notice;
- 28 out of 38 municipalities have published contracts on their websites.





Compared to last year (2020), based on seven (7) product indicators identical to the 2020 measurements, municipalities have had an increase in budget transparency of about 9% (from 64% in 2020 to 73% in 2021).


The average score for transparency in access to public documents and information policies is 69%.

The overall response of municipalities to requests for access to public documents is 89%. KDI sent 38 requests for access to public information and received a municipal response from 34 municipalities; four municipalities did not respond.

According to the information provided by the municipalities in response to the request from KDI, citizens submitted 745 requests for access to public documents in 34 municipalities that provided information for 2021. Of these, 359 were related to public procurement. Based on the information provided by the municipalities, out of 745 requests, only 13 were rejected on the basis of legal provisions on data protection/ confidentiality of information.

The municipalities with the highest number of requests for access to public documents were Prishtina with 87, Prizren with 65, Suhareka with 57, South Mitrovica with 53 and Ferizaj and Kaçanik with 50 requests for access to public documents.



The indicators with the lowest performance were:

- 1. "Are there any online tools that enable the public to submit and track their complaints/concerns/questions?" with 16% where only six out of 38 municipalities possess such instruments (Dragash, Drenas, Gjakova, Lipjan, South Mitrovica and Prishtina).
- 2. "Are the draft agendas of the mayor for public consultation published?", with 5% where only the municipalities of South Mitrovica and Rahovec publish them, and:
- 3. "Is the draft budget for public consultation published?" with 42% where only 8 municipalities publish draft budgets for consultation on their websites, 16 municipalities publish the draft budget through a call for public participation in budget hearings but not on their websites, and 14 out of 38 municipalities do not publish fare draft budgets for public consultation.



# **COLUMN V:** GRANTS AND SUBSIDIES

Grants and funding are additional activities through which municipalities spend the municipal budget.

To measure transparency in grants and funding, KDI used the following indicators:


- 1. Can the public participate in all hearings where grants are discussed or decided?
- 2. Are the rules governing potential conflicts of interest between the evaluating members of grants available on the official website?
- 3. Are specific criteria for awarding grants available on the municipality's website?
- 4. Are the grant award/rejection decisions available on the official website?
- 5. Is there the archive of decisions for awarding/refusing the grant for the last two years on the official website?
- 6. Have the evaluation reports for the award of grants been published on the website?
- 7. Is there information available on the municipality's website about subsidies allocated by the municipality?
- 8. How much money has the municipality allocated for subsidies for this year?
- 9. Has the annual report for the previous year on the subsidies given been published on the website?
- 10. Are the grant awarding regulations published on the website?

The average level of transparency in grants and funding is 69%.

The measurement found that out of 38 municipalities, the Municipality of Ferizaj is the only one that had published the evaluation reports for awarding grants on the website.



# **COLUMN VI:** PROFESSIONAL ETHICS AND CONFLICT OF INTEREST

Integrity is one of the key elements in managing public finances. Regarding the measurement of mechanisms to support integrity and the fight against corruption, mismanagement, conflict of interest and abuse of official power, KDI used the following indicators to measure the mechanisms of good governance in municipalities.

- 1. Does the municipality have a code of ethics?
- 2. Has the Integrity Plan been published on the website?
- 3. Is there an instrument for reporting unethical behaviour, discrimination or conflict of interest and has it appointed the responsible official in accordance with the law on the protection of whistleblowers?
- 4. Are political affiliations or memberships in political parties published for members of the assembly on the municipality's website?

The maximum score set in this column is eight, while the minimum score is zero. The table on the right shows the ranking of municipalities in this column.

The average level of transparency in professional ethics and conflict of interest is 45%.



The indicators with the lowest performance are:

- 1. "Are the mayor's property declarations available on the official website of the municipality?" with 13% where only five municipalities (Ferizaj, Kacanik, Lipjan, Prishtina and Rahovec) publish the mayor's wealth declarations on their website, and
- 2. "Has the Integrity Plan been published on the website" where only nine municipalities have updated plans (which include the measurement period) on their websites.

While 24 municipalities have specific instruments for reporting unethical behaviour, based on information received from municipalities, during 2021 there were 4 cases of alerting at the municipal level.





# **COLUMN VII:** MUNICIPAL PROPERTY MAN-AGEMENT AND AUCTIONS

Regarding the measurement of mechanisms for municipal property management, KDI used the following indicators to measure the mechanisms of good governance in municipalities.

- 1. Are property management regulations available on the official website?
- 2. Number of auction announcements on the municipality's website;
- 3. Number of auction announcements on the PPRC website; The maximum score set in this column is eight, while the minimum score is zero. The table on the right shows the ranking of municipalities in this column.

The maximum score set in this column is 10, while the minimum score is zero. The table on the right shows the ranking of municipalities in this column.

The average level of transparency in the management of municipal property and auctions is 67%.

The index shows that the number of public auctions continues to be small. Items sold through auctions have no high monetary value; however, the publication of these activities on the websites of municipalities is a legal requirement of Law no. 04/L-144 on Allocation for Use and Exchange of Immovable Property of the Municipality.

Furthermore, the procedures for public auction announcements and awarding are regulated through secondary public procurement legislation, and for this reason, their publication on the PPRC website is required.

This contradiction between the two laws mentioned above has led to 64 auctions being published on the websites of municipalities against only 10 such calls in e-Procurement (PPRC).

## **COLUMN VIII:** MUNICIPAL ENTERPRISES AND ORGANIZATIONS

Although only 16 municipalities have shares in municipal or regional enterprises, Kosovo citizens in all cities face the services provided by these companies on a daily basis (water supply, maintenance, transport, etc.). Meanwhile, in municipalities which have shares in municipal enterprises, they also have a financial impact by contributing to the municipal coffers, or making financial burden in case of low collections. To measure transparency in this public policy, KDI used the following indicators:

- Is the basic legislation on the organization, functioning and functions of public enterprises and dependent institutions published on the municipal website?
- 2. Is the organizational scheme for the involvement of public enterprises and dependent institutions published on the website of the municipality?
- 3. Are the annual financial reports of all public enterprises published on the municipality's website available?
- 4. Are the individual websites of the organizations related to the municipality (budget/subsidiary organizations, non-profit firms with the majority of shares in the region) linked to the official website of the municipality or do they have their section on the website of the municipality?
- 5.Number of companies with municipal investments
- 6. Are biographies of department heads available on the municipality's website, including information on:
  - education
  - previous employment

8. Has the municipality provided information regarding MED budgets for schools within its jurisdiction?


The index shows that municipal transparency in municipal enterprises and organizations is quite low, with an average of only 24% of the eight indicators mentioned above.

Out of 38 municipalities, only five publish the basic legislation on the organization, functioning and functions of public enterprises (Ferizaj, South Mitrovica, Peja, Prishtina and Rahovec).

Four of the 38 municipalities publish the organizational scheme for the inclusion of public enterprises and dependent institutions (South Mitrovica, Peja, Prishtina and Rahovec).

While only the Municipality of Ferizaj partially publishes the financial reports of public enterprises, the Municipality of Prishtina is the only one that links the individual websites of the enterprises with the website of the municipality, while no municipality has published the biographies of the board of directors of enterprises and municipal public organizations on the municipality's website including information on education.





# CONCLUSIONS

Kosovo municipalities have continued to show willingness to increase transparency in local government, especially in public procurement policies, budget and public finances, access to public documents and information, grants and subsidies, and public auctions.

However, the index highlights the need for local government engagement in increasing transparency regarding public enterprises and organizations, creating instruments to protect integrity and reporting unethical behaviour, and a greater commitment to public participation in the planning and decision-making processes of local government.

Although in 2021, the index was enriched with 46 indicators and two new public policies (increasing the number of indicators from 41 indicators to six policies in 2020 to 87 indicators extending to eight policies in 2021), 10 out of 38 municipalities in Kosovo have reached over 72 to 82 out of a maximum of 100 points.

However, the fact that we have four municipalities with a minimum score below 10 points remains a concern, which consequently, in addition to not being accountable to their citizens, also have a negative impact on the policy summary results and the overall index score.

Similar to last year's findings, also in 2021 new websites for all municipalities lack consistency, and municipalities are not clear on what information to present to the public.

The index continues to raise concerns about the naming of published documents and the place of their publication, due to the lack of clear instructions and rules from the central level that is the administrator of websites and public information.

The index also raises concerns about municipal contacts and capacity. 10 out of 38 municipalities do not have a municipal e-mail or an instrument to submit a request for access to documents or public information in electronic form. Also, the index had found cases when the names of responsible persons on the website did not correspond to the responsible persons in office as a result of the movements of municipal officials or staff.

Also, municipalities continue to face technical problems where uploaded documents cannot be opened.

# RECOMMENDATIONS

### Public procurement at the municipal level (61% out of 100%):

- Municipalities must publish the procurement plan, the annual procurement report for the previous year, tender notices as well as contract award notices.
- Except when it is not possible, we recommend that municipalities publish documents in legible formats (Word, Excel, Cvs, PDF machine readable)
- Furthermore, we recommend that all municipalities publish their contract notices and contract award notices, signed contracts as well as PRB decisions.

#### Budgeting and public finances (69% out of 100%):

• We recommend that all municipalities publish the budget, budget changes, investment plan, quarterly expenditure reports, summary report on the municipal budget for the previous fiscal year, medium-term budget framework, audit report and annual report on subsidies on the website of the municipality. The publication of these reports should be done in readable formats (Word, Excel, Cvs, PDF machine readable)

### Access to documents and public information (69% out of 100%):

• We recommend that all municipalities inform the public about what is considered protected data and information, in order to reduce the number of denials of requests for access to public documents and information.

 We recommend that municipalities develop and publish an official municipal newspaper, through which they briefly and illustratively inform citizens about municipal plans and developments at regular intervals.

#### Public participation (43% out of 100%):

- We recommend that municipalities publish the draft budget and draft agendas and decisions of the mayor for public consultation.
- We also recommend that all municipalities update the information regarding the relevant staff and provide contacts and mechanisms that enable citizens to submit their requests electronically.
- As a good governance practice, in order to further increase the transparency and accountability of locally elected officials, we strongly recommend that, although not part of this 2021 assessment, municipalities should also publish semi-annual and annual reports of the mayor, and annual municipal plans.

#### Grants and funding (69% out of 100%):

• In this pillar, we recommend that municipalities start publishing complete information (evaluation committee reports) regarding decisions on awarding grants and subsidies supported by municipalities.

### Professional ethics and conflict of interest (45% out of 100%):

- In this pillar, we encourage municipalities to follow the example of other municipalities by developing their own municipal codes of ethics, including the creation of adequate and specific instruments for reporting unethical behaviour.
- We also strongly recommend that municipalities update expired integrity plans and that all municipalities publish them on their websites.
- We also recommend that municipalities publish on their websites the asset declarations of mayors as well as the political affiliation of their leadership and members of municipal assemblies.

### Municipal property management and auctions (67% out of 100%):

• We recommend that municipalities publish the available property management regulations on the official website.

### Municipal enterprises and organizations (24% out of 100%):

We recommend that all municipalities whose citizens benefit from services of municipal or regional public enterprises, to publish on their websites the legislation governing the organization, functioning and functions of public enterprises, the organizational scheme where citizens can be given

a responsible or liaison position between the municipality and the enterprise or public organization as well as the annual financial reports of public enterprises and organizations.

- We also recommend that municipalities put on their websites the links of enterprises and public organizations that operate in their municipalities to prevent citizens from accessing information about the plans and activities of these enterprises,
- We recommend that municipalities ensure that companies or organizations who are shareholders publish the biographies of board members, as well as the publication of biographies of municipal leaders including information on their education and previous work experience.

# RECOMMENDATIONS FOR CENTRAL LEVEL GOVERNANCE

- The Ministry of Local Government Administration ٠ should develop Standard Operating Procedures for populating municipal websites, which should also include standard guidelines for naming files.
- Ministry of Local Government Administration, in cooperation with the Information Society Agency to update the websites of municipalities in accordance with the possibilities and requirements of modern technology and standards for data placement, including the establishment of API for all municipalities of Kosovo.
- The Ministry of Local Government Administration, in cooperation with the Public Procurement Regulatory Commission, to work on the continuation and finalization of the automatic population of notices related to public procurement on the websites of municipalities by being fed with information from the e-Procurement platform automatically.
- The Government of Kosovo to eliminate legal con-• tradictions regarding the publication of calls and decisions for public auctions.
